

## **Rights and Obligations of the Students accommodated in the Student Dormitories**

**Art. 18.** The people accommodated in the student dormitories have the right to:

1. Use the dormitory to meet their housing and educational needs in extracurricular environment and for recreational purposes without interfering to other tenants;
2. Occupy the same room for the whole period of their studies, if they have expressed preference for this and are classified for the respective academic year;
3. Make proposals through the Student Dormitory Council to the university administration and the Commission of Social Affairs for the improvement of living conditions;
4. Use the dormitory during the summer vacation, paying an additional rental fee;
5. Receive visitors under the Terms and Conditions set forth in these Regulations.

**Art. 19.** The people accommodated in the student dormitories are obliged to:

1. Know and observe these Regulations;
2. Use the dormitory with the care of a good owner and to protect the property;
3. Observe the established requirements for fire protection;
4. Observe all established sanitary and hygienic requirements;
5. Not hinder other occupants of the student dormitory in the exercise of their rights;
6. Be respectful to the staff in the buildings of the student dormitory and to not interfere with the exercise of their rights and the practice of their duties;
7. Pay by the 10th of the current month the determined dormitory rental fee;
8. Pay all amounts due specified in the internal acts of the University of Plovdiv;
9. Present to the manager of the corresponding building their student book with verified relevant semester within 30 days from the beginning of the summer semester;
10. Provide 24-hour access to the manager and authorized officials to the occupied housing in order to prevent accidents, and to exercise access control;
11. Vacate the dormitory after they no longer have the right to use it;
12. Hand over the room and the received property upon final departure from the dormitory, as well as to pay all amounts due at the University Cash Desk;
13. Register their guests in the Visitors Register / Guest Book.

**Art. 20.** The people accommodated in the student dormitories are prohibited to:

1. Throw away any objects, materials and waste in and around the buildings of the dormitories;
2. Self-accommodate and move from one room to another;
3. Move property from one room to another without the permission of the manager of the respective building;
4. Export outside the dormitory the property assigned to them by the manager, as well as the common property;
5. Renovate the installations, to build new ones and to replace the door locking devices without the permission of the manager;
6. Hand over their personal access control chips to other people;
7. The import, production, processing, trade, use and storage of plants, substances and their analogues - classified as narcotic and psychotropic substances with narcotic impact under the Narcotic Substances Control Act and its applications, in the student dormitories;
8. Smoke and use of other means of smoking, including hookah, in the rooms of the student dormitory;
9. Bring moto and bicycles into the buildings;
10. Use electrical appliances for cooking, except for microwaves and electric kettles, as well as electric heating appliances;
11. Bring and keep animals in the buildings of the student dormitories;
12. Exercise physical or mental violence against the tenants, visitors and workers in the student dormitory buildings.

## **Access Control**

**Art. 12.** The access in the student dormitories is 24/7 and is carried out through a personal access control chip;

**Art. 13.** From 22:00 to 08:00 only tenants are allowed to stay in the student dormitories;

**Art. 14.** The hours from 14:00 to 16:00 and from 22:00 to 08:00 are time for rest;

**Art. 15.**

- (1) The residents of the student dormitories may receive guests from 08:00 to 22:00;
- (2) The access of guests in the buildings shall take place after presenting an Identity Document (ID) and registering in the Visitors Register / Guest Book;
- (3) The Visitors Register / Guest Book shall indicate the hours of the visitors' entry into and exit from the building;
- (4) The visitors shall be met personally by the person living in the building, whom they are visiting;
- (5) The residents of the student dormitories shall be responsible for the guests' observance of the established rules.
