ISCTE-IUL offers proper infrastructure to welcome students and staff with disabilities. In case the partner university intends to send a student with a specific disability should inform IRO in advance so that all can be prepared.

- 2. The receiving institution will send its decision within 3 weeks.
- 3. A Transcript of Records will be issued by the receiving institution no later than 3 weeks after the assessment period has finished at the receiving HEI.
- **P LISBOA07:** ToR will be issued by ISCTE-IUL no later than 4/5 weeks after the assessment period has finished and final classifications are placed on the system.

The IRO of ISCTE-IUL will send the transcript of records to the IRO of the student's university in case grades are not yet available when student leave.

ISCTE-IUL will NOT automatically send the transcript to student's home.

4. Termination of the agreement

A notice of at least one academic year should be given for the termination of the agreement. This means that a unilateral decision to discontinue the exchanges notified to the other party by 1 August 20XX will only take effect as of 1 August 20XX+1. Neither the European Commission nor the National Agencies can be held responsible in case of a conflict.

1. Grading systems of the institutions

In the Bulgarian System, marks are graded from 2 to 6, with 3 being the minimum score required to pass:
